To assume full responsibility for the care of the instrument until it is returned to the school and to reimburse Rocky View Schools for any loss of, or damage or destruction to, the instrument loaned to them.* 3. To be responsible for minor repairs occasioned by the use of the instrument, such as replacement of water key corks, pads, etc. 4. To return the instrument in the same condition to the school from which it was issued. 5. To return the instrument to the music teacher before the last day of the school year or as directed. 6. To pay the required non-refundable rental fee, when this application is submitted, knowing that no refunds are permitted under any circumstances. 7. The student shall attend all scheduled rehearsals and performances except in the case of illness or when excused by the music teacher. 8. Negligence on the part of the student, either in their care of the instrument or in their attendance at practices, which shall be determined solely by the school, will negate and cancel all privileges extended by this agreement and shall require the return of the musical instrument to the music teacher on demand. <p>*Parents should carry their own Homeowner's Policy Insurance Protection against loss, theft, etc.</p>
